Once again in 2016 the Community Foundation Serving the Heart of Western Pennsylvania has provided scholarships and grants to schools and nonprofits throughout Armstrong County and western Pennsylvania. Your support has enabled the Community Foundation to award a total of \$502,644; \$329,774 in grants to deserving local nonprofit organizations and \$65,250 in post-secondary scholarships to local students, plus 107,620 in Educational Improvement Tax Credit scholarships to private school students! For example, we have helped Blessings in a Backpack fight hunger by sending food home with local eligible children to make sure they have enough to eat.

THE MARKET STREET REVITALIZATION PROJECT

As the "Main Street" in Kittanning's commercial/business center, Market Street is the core of our community. It tells the "Kittanning Story" as nothing else can. It reminds us of colorful parades, window shopping during the holidays, and special evenings with friends and family. But like other "Main Streets" around the country, Market Street has experienced a decline.

The Downtown Kittanning Revitalization Committee, in cooperation with input from the community, decided that a master plan with real impact should be considered and designed in phases which will encompass Market Street in its entirety from Water Street to the Armstrong County Courthouse.
