We are often asked,

WHAT IS A COMMUNITY FOUNDATION?

As a registered 501©3, the Armstrong County Community Foundation is a tax-exempt, nonprofit, publicly supported philanthropic organization with a goal of creating permanent, named funds for the public in our region.

As with most community foundations, we hold our endowments in separate funds established by individuals, families, businesses or other charitable organizations.

The mission of nearly every community foundation is to enhance the quality of life in the local area. We carry out this mission by building permanent endowment funds and using a portion of the annual income to support a variety of local nonprofit organizations through grants and special programs.

All of the Armstrong County Community Foundation funds are endowed.

WHAT IS AN ENDOWMENT?

An endowment is a fund that creates income for charitable purposes. Endowment funds only distribute a percentage of the income from the fund without ever distributing from the principal. We distribute 5% of the fund income to area nonprofits annually.

HOW DO WE WORK?

All community foundations are operated and organized independently. We at the Community Foundation are governed by a ten member board of directors and administered by two staff members. Our operating expenses are paid by our

annual fund fee and by gifts designated for operating and program expenses as well as a percentage from EITC contributions.

HOW ARE WE DIFFERENT FROM PRIVATE FOUNDATIONS?

Private foundations typically receive funding from a single source instead of funding from the general public and do not qualify as public charities.

As a community foundation, we are supported by a wide range of individuals, families, corporations and others. The Foundation and our donors all have a strong desire to improve our local communities.

As a community foundation, we are permitted to treat all of our funds as component funds under a single corporation.

Like other public charities, however, community foundations must continually meet the Public Support Test to keep their charitable status.

WHAT IS THE PUBLIC SUPPORT TEST?

To be classified as a public charity, the community foundation must demonstrate to the IRS that the community broadly supports it. Usually this means that at least one-third of its income comes from contributions from a diverse group of donors. If too much of its income comes from (1) a single donor or (2) investment income, it runs the risk of being reclassified as a private foundation.

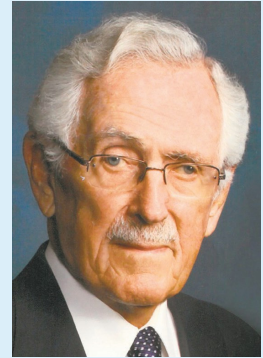
Each year in May, we send out a formal request for proposals. These grants are awarded at our Annual Dinner which is held the first Tuesday in October.

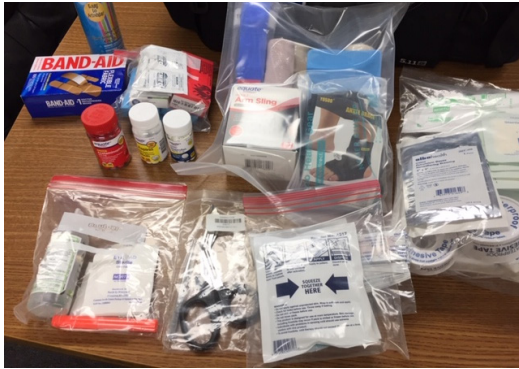

The Richard G. and Barbara A. Snyder Charitable Fund awarded the Fort Armstrong Horsemen's Association with a \$5,000 grant to update and upgrade equipment necessary for the Crooked Creek Horse Park to function. Priority is to be given to the plumbing in the shower house and failing sand mound.

The Richard G. and Barbara A. Snyder Charitable Fund also awarded \$900 to the Kittanning Community Band to purchase a complete drum set to greatly enhance the quality of the band performance and expand the style of music it can perform.

The Jamie and Mindy Owen Fund awarded \$350 to the ACMH Foundation. Through the implementation of a veterans' treatment court, ACMH Foundation has created a restricted fund to facilitate the receipt of donations from foundations, employers and individuals who want a way to give back to those who have served our country.

Gary and Janet (Bell) Pettengill Scholarship Fund

Gary approached the Community Foundation after the unexpected death of his wife

Janet, or AJ as she was known by her nieces. For those who knew Janet, she had the heartiest laugh, enjoyed life to the fullest and when she loved you, she loved you with all of her heart!

The purpose of the Gary and Janet (Bell) Pettengill Fund is to provide funds for a high school senior graduating from a high school in Armstrong County enrolled in any field of study. The recipient must be enrolled in an accredited college, university, trade or technical school in the US.

Tut Toth Memorial Scholarship

The Tut Toth Memorial Scholarship Fund is supported by family and friends through an annual memorial baseball tournament. At the time of his death in 2011, Douglas "Tut"

Toth was the league's player agent and manager/coach for a softball and a baseball team. He was active in many local non-profits and youth sports programs, but was dedicated especially to New Bethlehem Little League. He is still the only person in NBLL to have been on a District Championship team as a player

and then as an adult to be the manager of a District Championship team. Tut was instrumental in the beginnings of Little League softball in New Bethlehem and led that team to the first D25 softball win for New Bethlehem. The memorial scholarship is available to students who participated in New Bethlehem Little League, graduate from Redbank Valley High School, maintain their GPA and participate in community service. It will be awarded on a competitive basis requiring an essay as part of the application.

Dr. A.I. Slagle Medical and the Mabel R. Slagle Nurses Training Scholarship Funds

Augustus Ira Slagle, MD was a practicing physician from Westmoreland County. He was born January 25, 1884 to Samuel J. and Jennie Linweber Slagle. He married Mabel R. Slagle who passed on September 3, 2006.

This Fund consists of two scholarships. Both are available to adult students who have graduated from Apollo Ridge High School, Armstrong High School (including Kittanning High School and Ford City High School), Kiski Area High School, or Leechburg High School.

The Dr. A.I. Slagle Medical Scholarship is for students entering their first year at an accredited medical school in the US to obtain an MD or DO. Approximately \$65,000 is available and is a 4-year renewable scholarship if the student remains in satisfactory academic standing.

The Mabel R. Slagle Nurses Training Scholarship is for students enrolled in a nursing program at an accredited college/university in the US OR a student entering (first year) a nursing program at a recognized hospital training school. Approximately \$35,000 is available and is a 4-year renewable scholarship if student remains in satisfactory academic standing.

Mechling-Shakley Veteran's Center

The Mechling-Shakley Veteran's Center Executive Director and Board of Directors established the Mechling-Shakley Veteran's Center Organizational Fund to ensure that the Veteran's Center would maintain funding into perpetuity.



Rumbarger Emergency Fund

The Rumbarger Emergency Fund was established due to the generosity of a local gentleman's insurance policy. Unbeknownst to the Foundation, this unrestricted surprise has enabled the Community Foundation to begin an Emergency Fund to ensure that the Foundation has resources to continue our work in the event of difficult times.

UPMC HEALTH PLAN

The Community Foundation is approved through the Educational Improvement Tax Credit (EITC) program to accept donations from businesses that are approved by the Department of Community & Economic Development (DCED).

This means the approved businesses may contribute to the Community Foundation and, in turn, the Community Foundation awards scholarships to students wishing to attend private or faith based schools for Pre-K and K-12.

What is the advantage?

A business may receive a tax credit equal to 75% of its contribution to the Community Foundation up to a maximum of \$750,000 per taxable year. The tax credit may be increased to 90% of the contribution made, up to a maximum of \$750,000 per taxable year, if the business agrees to provide the same amount of contribution for two consecutive years.

What is the process for a business to receive the tax credit?

A business must apply to DCED for the tax credit. Tax credits are awarded on a first-come, first-served basis starting on the first day of the new fiscal year. Businesses can download an application at www.newpa.com/eitc. After approval by DCED, a business must make its contribution to an approved Scholarship Organization(s) within 60 days. Once the business receives confirmation of their donation and sends that into DCED, the tax credit will be awarded.
