# ARMSTRONG COUNTY COMMUNITY FOUNDATION & NEXTIER BANK PARTNER TO DELIVER FUNDS TO LOCAL FOOD BANKS

The Armstrong County Community Foundation and NexTier Bank completed a partnership to provide funding to the Armstrong County Community Action Food Bank. Together, the organizations provided \$12,600 in funding. The recent COVID-19 pandemic has resulted in layoffs throughout the county and a substantial need for food and essentials for many residents.

"Given the current environment and ongoing challenges of the pandemic, the Armstrong County Community Foundation felt that a donation to local food banks would be the most effective way to support our community," said Jodi Beers, Executive Director of the Foundation. "Insuring that our local food banks have the funding necessary to continue to provide food to community members helps to alleviate one of the many concerns that families have. Many families are accessing food banks for the first time and it can be an overwhelming experience."

"This is a challenging time for many families in Armstrong County. At NexTier Bank, we felt that partnering with the Armstrong County Community Foundation by providing funding to insure that families have access to nutritious meals would be the best way to help families that are struggling right now. It's an opportunity to strengthen and sustain our community as we try to navigate the new normal," stated Maria Amoruso, chief marketing officer at NexTier Bank. "This crisis is both a health and a financial crisis for unprecedented numbers of people. We hope this donation will help bridge the gap until businesses are able to fully re-open and people are able to return to work."

# THE 2020 ARMSTRONG DAY OF GIVING FACED AN UNPRECEDENTED CHALLENGE WITH THE COVID-19 PANDEMIC.

Regardless, the Armstrong Day of Giving was held from July 13-17 in partnership with NexTier Bank. It was decided that it would be extended to include not only the Day but the Week of Giving. With everyone working short staffed and working from home, a week of giving proved to be a much easier process for not only the nonprofits but for the community.

With all of the obstacles of the pandemic, the Day of Giving generated \$210,484.37 in funding for 26 participating non-profit organizations.

During the 2020 event, Orphans of the Storm was the top fundraiser with a total of \$33,007.92.

#### Applicants for the Quality Life Services Scholarship must:

- Be a high school senior whose parent or grandparent is currently employed by a Quality Life Services Company
  - (An employee of Quality Life Services may apply if that employee fulfills all other qualifications of the scholarship and is able to obtain a sponsor within the facility in lieu of a parent or grandparent. This would be someone in a supervisory role (i.e. Director of Nursing, Shift Supervisor, Director or the facility, etc.) One of the recommendation letters for this scholarship must be from this individual.
- Be accepted full-time at an accredited two or four year college, university, nursing or vocational school in the United States with a declared major in a healthcare field employed by Quality life Services
- Have attained a minimum 3.0 GPA



# THE HOPE OF THE KAY DETRICK OWEN SCHOLARSHIP



"Thank you seems so small and insignificant, but those are the only words I can think of right now. Thank you for sharing my journey with me. The road seems much less scary and lonely because of you."

Those are the words in a note written by my very first client in 1974. I was a counselor in a Peer Counseling program at IUP. Those words melted my heart and cemented my desire to become a counselor as my life work. About a year later, I applied for a job at a drug and alcohol treatment center in a little town that I had never heard of--Kittanning. The place was ARC Manor. I was hired; and as they say, the rest is history. I spent my full professional life of 32 years there. I had many different positions: Treatment Aide, Counselor, Therapist Supervisor, Clinical Director, and Executive Director.

Upon my retirement in 2008, I did not want a party, a plaque, a watch, a clock or any other gift. With infinite wisdom and foresight, the Board of Directors for ARC Manor and the ARC Manor Foundation established a Scholarship Fund in my name at the Armstrong County Community Foundation. The intention of this scholarship was to support students who desired to enter the human service field as their profession. The scholarship was established to provide funds for a high school student and an adult student seeking an advanced degree. I hope that the Kay Detrick Owen Scholarship assists those whose goal is to enter the helping profession. They might become a Counselor, a Therapist, an Addictions Specialist, or a Social Worker. They may specialize in addictions, child welfare, domestic violence, aging, delinquency, sexual assault, mental health, marriage or family. The key thing is that they want to address and reduce human suffering.

Many scholarships are established after someone's death to honor them. I have had the good fortune that my scholarship was established to honor my career while I am still alive. Each year, I have the pleasure and honor of sitting on the committee that reviews the applications and assists in the selection of the scholarship recipient.

Who knows??? Maybe the recipients of the Kay Detrick Owen Scholarship will go on to get notes from their clients like I did. Or maybe some day they may become an Executive Director.



#### **Downtown Kittanning Revitalization**

The Downtown Kittanning Revitalization Committee (DKRC) is grateful for the Grant received from the Armstrong County Community Foundation in September, 2020, which allowed for the Hanging Baskets to return to Market Street in Downtown Kittanning. These funds were used to assist in the cost of installation, plantings, watering, and the fertilizing of the baskets themselves. These hanging baskets provide necessary greenery and color, and they contribute to the attractiveness of our recently revitalized main street.

DKRC's mission is to advocate for and implement special projects that improve community design, enhance the environment, and foster economic development in Kittanning Borough and in the Kittanning area.

#### **Progressive Workshop**

The Progressive Workshop of Armstrong County operates a Small Group Employment Program for individuals who have been diagnosed with an intellectual, physical, or emotional disability. Trainees enrolled in Small Group Employment work in the community under staff supervision. On September 10, 2020, the Progressive Workshop of Armstrong County expanded its Small Group Employment Program with the grand opening of Progressive Document Destruction.

Progressive Document Destruction offers several affordable options for business and residential customers within a 75-mile radius of Armstrong County and follows all HIPAA compliance regulations when storing and destroying documents. Shredded documents are then baled by PWAC and recycled.



Progressive Document Destruction is operated out of PWAC's Leonard M. Meneely Industrial Center which is located on Water Street in Kittanning Boro.

In 2020, the Progressive Workshop of Armstrong County was awarded a grant from the Armstrong County Community Foundation to customize an existing box truck with the Progressive Document Destruction logo. This has allowed current and prospective customers to easily identify the service when staff are driving in the community. Finally, PWAC also offers mobile shredding and the use of a box truck with logo has helped PWAC to expand the service to additional customers, and in turn, to offer more employment opportunities to our trainees.

#### **TryLife Center**

TryLife Center (TLC) is a 501(c)3 pregnancy and family resource center which inspires hope in at-risk families by contributing to the physical, emotional and material well-being of young impoverished mothers and fathers with infants and young children. Frequently we counsel a young, pregnant at-risk mother facing financial hardship. She, therefore, cannot afford a crib, mattress, car seat, diapers and formula for her infant. At other times, we see parents who work two or three part-time jobs and are still unable to make ends meet.

For all families in Armstrong and neighboring counties in need of hope, guidance, and a listening ear, our doors are always open; we do not turn anyone away. We offer practical solutions and positive opportunities to explore options for the problems that confused, fearful mothers and fathers face. Whether it is a lack

of basic necessities for their babies and children, mentoring in positive child rearing or counseling services to improve the family unit, TLC offers hope, guidance and fresh alternatives to parents that they may not know exist.

#### **Ramps of Hope**

Ramps of Hope is a ministry associated with the United Methodist Church whose mission is to enhance the lives of people with limited mobility by providing them with ramps for easy and safe access in and out of their own homes. The work is done entirely by volunteers so there is no cost for labor. Recipients are not charged for their ramps, rather they are asked for a donation of whatever they can afford for the ministry. This may help offset the cost of the materials for their ramps. Even if they cannot afford a donation, their ramp will still be built. Cost of the ramps vary depending on the size of the ramp, but most are in the \$500 to \$1500 range. (Ramps have been costing more since the pandemic began as the cost of treated lumber has greatly increased.) Ramps are built in sections and are considered temporary. When one is no longer needed

at a home, a ramps team will recover it so the sections can be recycled into new builds. This helps keep costs down. The program is funded primarily through grants and donations from churches, recipients and their families/friends, other individuals, and community organizations. The ramps change people's lives. Volunteers have seen recipients go from despair to utter happiness when they step or roll onto a ramp and realize they are no longer "prisoners" in their own homes. The look of joy that comes over their faces is reason enough to keep building ramps!

#### **Arc Manor**

ARC Manor's Board, staff, and clients all appreciate the support that we receive from the Armstrong County Community Foundation. This year has been particularly difficult for our community, and we are grateful to receive the grant to allow us to continue to provide treatment to those in need. In a time of feeling isolated and alone, our community is vital in keeping us connected to each other. The Community Foundation helps us keep a focus on building a bright future for individuals and our community.



#### **LifeSteps**

We conducted zoom classes at the Armstrong County Program Center. The grant funds provided by the Armstrong County Community Foundation helped purchase laptops, microphones, a webcam, and a smart TV to be used for virtual and in-person programming for adults with disabilities. The technology has been crucial in assisting the program and supporting individuals during COVID-19 and it will benefit the program beyond the pandemic. Lessons include a range of educational topics and skills such as employment, nutrition, cooking and fitness.

# **NEW FUNDS**

#### Dr. Henry E. & Victoria B. (Halas) Reich Memorial Scholarship

The Dr. Henry E. & Victoria B. (Halas) Reich Memorial Scholarship was established in their memory to provide financial assistance to graduating seniors of Armstrong High School who wish to pursue a college degree.

Dr. Reich (1923-1993) and his wife Victoria (1925-2008) grew up in Ford City and lived there for many years. They both graduated from Ford City High School and believed strongly in the value of a higher college education.

Dr. Reich graduated as valedictorian of his 1942 Ford City High School class and lettered three years on the varsity basketball team. After his service with the US Army in WWII, he attended the Carnegie Institute of Technology and then the University of Pittsburgh to obtain a doctorate degree in chemistry. This degree enabled him to have a very successful professional career in the chemical and petrochemical industries.

Victoria Reich graduated near the top of her 1943 Ford City High School class and went on to receive a registered nursing degree from West Penn School of Nursing. She successfully raised a family of four children while employed as a nurse at PPG Industries and other health care facilities.

It is hoped that this scholarship will assist a student to attain his/her goals through the higher education Dr. & Mrs. Reich valued so highly.

#### Charles, Jr. and Louella Snyder Charitable Trust Designated Fund

The Charles, Jr. and Louella Snyder Charitable Trust fund held at the ACCF was started in early 2020; however, it had been discussed over a number of years prior. Six organizations are supported through this fund.

After living in East Franklin Township all their lives, the Volunteer Fire Department was supported each year. The Salvation Army does many things for the community when disaster happens and also coordinates programs for adults as well as children.

Habitat for Humanity has always been there to help improve living conditions for families in need. The Richard G. Snyder YMCA supports everyone young and old with various programs and swimming. Grace Christian School is where their great grandchildren attend. The researchers at the Snyder Lab at the Eye and Ear Institute are studying to cure and help those with macular degeneration of the eye and other disorders.

These nonprofit organizations are the organizations that were prominent and supported by Charles, Jr. and Louella Snyder all their lives; and now, thanks to this fund, it will continually support these for a very long time to come.

## **Alpha Lillstrom Cheng Democratic Process Engagement Scholarship Fund**

Alpha Lillstrom Cheng JD, MA is from the New Bethlehem area and a 1993 graduate of Redbank Valley High School. Alpha has dedicated her career to public service and empowering Americans to participate in elections as well as the legislative and regulatory processes. As rural America is often overlooked by political candidates and party platforms, this scholarship is intended to provide financial support to Redbank Valley High School graduates who are interested in giving back to their community and country through the democratic process.

Applicants attending a college, university or graduate program studying Anthropology, Sociology, Public Policy, Political Science, Journalism, or Law are eligible. Additionally, a person may also be eligible if they have secured an internship with a state or federal legislator or someone who is running for a local, state, or federal elective office or if they are a candidate for a position in local or state government. The scholarship will be awarded on a competitive basis requiring an essay as part of the application.

## **DESIGNATED FUNDS**

Because it's given through your community foundation, your gift provides the organization(s) you select not only funding, but planned giving and investment management services and the power of endowment. What this means is that the approved businesses may contribute to the Community Foundation; and in turn, the Community Foundation awards scholarships to students wishing to attend private or faith based schools for Pre-K and K-12.



#### What is the advantage?

A business may receive a tax credit equal to 75 percent of its contribution to the Community Foundation up to a maximum of \$750,000 per taxable year. The tax credit may be increased to 90 percent of the contribution made, up to a maximum of \$750,000 per taxable year, if the business agrees to provide the same amount of contribution for two consecutive years.



#### What is the process for a business to receive the tax credit?

A business must apply to DCED for the tax credit. Tax credits are awarded on first-come, first-served basis starting on the first day of the new fiscal year. Businesses can download an application at www.newpa.com/eitc. After approval by DCED, a business must make its contribution to an approved Scholarship Organization(s) within 60 days. Once the business receives confirmation of their donation and sends that into DCED, the tax credit will be awarded.






