# 2018 ANNUAL REPORT Message from the Executive Director & President

#### Dear Friends,

The Armstrong County Community Foundation celebrated its twentieth anniversary with a festive evening at the Lenape Heights Golf Resort. Over onehundred thirty attendees enjoyed a dinner of filet mignon and salmon and had the opportunity to win one or more of over fifty prizes. Dinner and prizes over, the highlight of the evening was the awarding of \$20,000 in grants to ten eligible non-profit organizations.

It was a busy year for the foundation's executive director, president and board members who were, as always, working on a number of projects and campaigns.

- They brought back the Day of Giving to the Community Foundation; and, on May 10, 2018, spearheaded the raising of over \$330,000.
- They awarded \$69,250 in scholarship money to area students.
- They provided board training by the Pennsylvania Association of Non-Profit Organizations. For any interested non-profit wishing to participate.
- They educated area businesses and clubs on the mission and operations of the Foundation.

The ACCF is blessed to have a board that is hard working, hands on and committed to improving and sustaining the community which they serve.

Our directors, in closing the outstanding anniversary year of 2018, voted to go back to our roots and officially return to the name Armstrong County Community Foundation. # Paying it forward

Getting to know our funders is one of the most rewarding parts of our job here at the Foundation. We have the privilege of meeting and working with all levels of Funders, but what they all have in common is their kindness and desire to be charitable in our community. I recently had the wonderful opportunity to sit down with one such individual.

William (Bill) Toy was born on April 1, 1929. As a young teenager, Bill worked for a local dry cleaner doing clean-up work. The owner took a liking to Bill and began to show him the ropes of the business. Bill worked there until he graduated



from Kittanning High School in 1950 at which time he went on to graduate from the Institute of Dry Cleaners and opened the Spic and Span Dry Cleaners plant in Ford City on November 7, 1950. His future father-in-law at the time assisted him with acquiring the funds to start the business and in 1951 Bill tied the knot and married his wife Dorothy.

Dry Cleaning was in high demand at that time, so despite the fact that there were 18 different outlets for Dry Cleaning services in the Kittanning/Ford City area, Bill had great success and went on to open a second store in Kittanning in 1951. Since then, he has seen many changes to the business. Due to his keen business sense and work ethic he has been able to diversify his businesses and continue operating his stores for nearly 70 years, currently employing 25 local individuals. He still works every day starting at 3:30 am!

"With the ever changing needs of the world, dry cleaning is not needed as in years past," Bill said. The cost to create draperies has sky rocketed so now he creates more blinds than draperies. In 1984, Spic and Span expanded into the linen business and now services many of the catering businesses in the Pittsburgh area.

As an avid sailor who enjoys sailing the Chesapeake Bay in his free time, Bill found a way to bring this passion into the business. In 1985 he opened Sail Care in Ford City. There are 100,000 sails in use today that have been given new life with sail cleaning and re-resining, sail repair and modification, and custom graphics by Sail Care.

Bill feels grateful to our community for the support he has received throughout the years and wanted a way to give back. On August 9th, 2012, Bill created the William H. and Dorothy S. Toy General Charitable Fund, a Donor Advised Fund. This Endowment Fund supports the nonprofit community by making grants to Armstrong County nonprofits every year and will continue to do so for many years to come! To date, the William H. and Dorothy S. Toy General Charitable Fund has awarded over \$30,000.00 in grants!

"The 4-year scholarship that I received helped greatly by reducing the total amount of student loan debt that I accrued during college! It also allowed

me (and my parents) to worry less about money and focus on my classes. I am thankful for the scholarship every month when I pay my student loan payment; I was able to budget for a 10-year repayment plan so I only have a little less than 3 years to go. My education included 6 years at the University of Pittsburgh, 4 of which were spent in the School of Pharmacy. I graduated summa cum laude with my Doctorate of Pharmacy degree in 2010. I currently am a faculty member at a School of Pharmacy in upstate New York where I get to work as a clinical pharmacist at one of the area hospitals and teach future pharmacists and physicians how to care for patients."

"Receiving the scholarship helped my family and I to finance my undergraduate education at Carnegie Mellon University. I graduated from Carnegie Mellon in

2009 with a Bachelors of Science in Business Administration and developed a passion for education during my time as a student there. After graduating, I decided to pursue work in the field of higher education and took a job with the Office of Admission at Carnegie Mellon and later continued my education at Drexel University where I received a Masters of Science in Higher Education. I currently serve as an Associate Director of Admission at the university. This is a position that has afforded me the opportunity to further the mission of providing access to higher education both through my professional work for the university and through service to regional and national non-profits like the Pennsylvania Association for College Admission Counseling and the National Association for College Admission Counseling. The support of the Foundation helped me to achieve my educational goals, and I hope that my professional and service work today will provide similar support to others as they seek to pursue higher education."

# The Dr. John Garrott Memorial Scholarship by Marian Garrott

The Dr. John Garrott Memorial Scholarship was established in 2007 by the Cowansville Area Health Center Board of Directors. It was set up in honor and memory of him. He knew about the scholarship before he passed. John had worked at Cowansville for a number of years as a Board Certified Family Practice "Doc". He was genuinely touched knowing that all the hard work and devotion shown to his patients really did matter.

John was a staunch advocate on the importance of education, always encouraging others. Kelly Scholl, a Cowansville Board member came to the house to inform us about his scholarship. She had worked at Cowansville with John as a Medical Assistant. John had delivered her three "kiddos". John being John saw promise in Kelly and encouraged her to pursue her dream of becoming a Registered Nurse. While raising her family, she enrolled at West Penn Hospital's School of Nursing. She achieved her "RN", began working at Armstrong County Memorial Hospital on their Obstetrical/Gynecological Unit and once again, working with John.

John's scholarships are awarded to high school students, college students, and medical students pursuing a career in nursing or the medical field. One recent recipient, Kate Gass, receiving in 2015-2016 is an ICU Nurse working at ACMH. John delivered her and had worked with her mom at Cowansville. The scholarship helped her to return to school to receive her Bachelor of Science Degree in Nursing.

It has been an honor and privilege to be able to participate in John's scholarship selection process through the years. ACCF's Board Member Chris Moss, heads the scholarship selection committee. She and her hard working selection committee deserve much gratitude and credit. They review all of the numerous applicants who are hoping to receive a scholarship from "the Community Foundation".

# During our Annual Dinner, \$20,000 in grants was awarded from the Founders Fund.

In early summer, requests for grant submissions are advertised to all of the area nonprofits as well as advertised in the local newspapers and on social media. An independent committee reviews, scores and then discusses all of the submissions. These winners are then approved by the Foundation's Board of Directors.

**Hose Company #6** was the top winner in the General Grant Category receiving \$4,000 to provide additional funding for the boat motor on a water rescue craft

**Ramps of Hope** - \$2,500 to change the lives of people in need by building handicapped access ramps at their homes

**Fort Armstrong Folk Festival** - \$2,500 to purchase a stage for their North Stage entertainment area

**Hose Hook & Ladder Co. #1** - \$2,000 to replace aging equipment – Task Force Tip Vortex nozzles & Straight Tips

**Don't Stop Dreamin** (In the Moment) -\$2,000 to fund an art therapy project for residents/patients living with dementia and Alzheimer's in the Quality Life Services' continuum of care.

**Richard G. Snyder YMCA** - \$2,000 to provide bussing for 7-12 grade students from Armstrong HS to participate in a FREE After-school program (MAD) **Evangelical Lutheran School** was the top winner in the Children's Grant Category and received \$2,000 to provide help to families who need assistance with early education as well as to help families that may develop a need throughout the school year.

**Grace Christian School** \$1,000 to provide funding for an Ozobot Evo Classroom Kit to teach coding, STEM, art, history and subjects beyond STEM.

**Biblical Life Institute (BLI)** \$1,000 to provide scholarships for participation in "Hoop Dreams", a summer basketball program for youth from 5th – 12th grade.

**Blessings in a Backpack** \$1,000 to provide food for elementary school children who have little or no food to eat on weekends during the school year.

## UPMC HEALTH PLAN





Since 2001, the Community Foundation has been providing scholarships to students totaling over \$3.8 m for Pre-K and K-12 families in Armstrong and Butler Counties.

Thanks to the generosity of local companies who participate in the Educational Improvement Tax Credit (EITC) program, the Community Foundation has been providing scholarships to local families who live or work in Armstrong and Butler counties. These scholarships provide assistance for their children to attend private schools of their choice. Parents choose to send their children to private or faith-based schools for a variety of reasons, and this scholarship program allows those parents who could not otherwise afford the tuition to make the decision that's best for their families.

## How do children qualify?

To qualify for the K-12 scholarship, the parents of the student must either reside in or be employed by a company located in Armstrong or Butler Counties.

To qualify for the Pre-K scholarship, the parents of the student must reside or work in Armstrong County only. An eligible student is a school age student (Pre-Kindergarten through grade 12) who is a resident of Pennsylvania, enrolled in a school in this Commonwealth, and a member of a household with an annual household income of not more than \$85,000, except that an additional income allowance of \$15,608 is permitted for the student and for each other dependent (as defined by the IRS) living within the same household.

## What is the Educational Improvement Tax Credit?

The EITC Program is funded by contributions from participating businesses. Eligible businesses are those that pay any of the following taxes in Pennsylvania: Personal Income Tax, Capital Stock/Foreign Franchise Tax, Corporate Net Income Tax, Bank Shares Tax, Title Insurance & Trust Company Shares Tax, Insurance Premium Tax (excluding surplus lines, unauthorized, domestic/foreign marine), Mutual Thrift Tax, Malt Beverage Tax or Retaliatory Fees under section 212 of the Insurance Company Law of 1921.


